What is the purpose of this update?

Small differences in fees and charges can have a big impact on your investment over the long term.

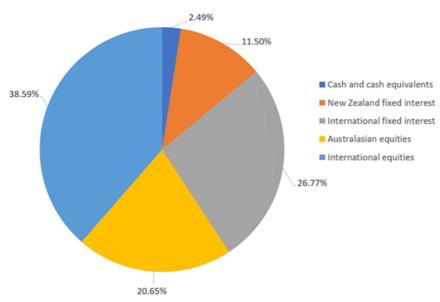
Anthony had \$10,000 in the fund when the fund received its first contribution, on 28 September 2020, and did not make any further contributions. At the end of the period to 30 September 2020, Anthony incurred a loss after fund charges were deducted of \$29 (that is -0.29% of his initial \$10,000). This gives Anthony a total loss after tax of \$24 for the period.



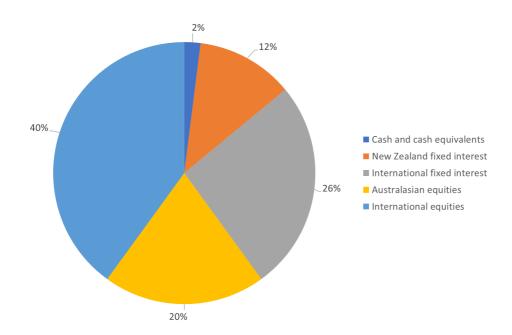
What does the fund invest in?
