


Image: Abstract aerial view of river bed, Canterbury Plains, Christchurch, NZ.

## Changes relating to the scheme

On 22 August 2017the Nikko AMGlobal Shares Fund was registered.

On 3 August 2017 the SIPO was updated, replacing the version dated 1 March 2017. This update was made to reflect the launch of the Nikko AM Global Shares Fund.

On 7 September 2017 the SIPO was updated, replacing the version dated 3 August 2017, to reflect changes made to the structure of the Nikko AM NZ Corporate Bond Fund, in that a Nikko AM Wholesale NZ Corporate Bond Fund was launched and the Nikko AM NZ Corporate Bond Fund commenced interfunding in to that fund rather than holding securities directly.

On 29 September 2017, the SIPO was updated, replacing the version dated 7 September 2017, to reflect a change of investment objective for the Nikko AM Income Fund.

We confirm that there were no related party transactions entered into during the accounting period that were not on arm's-length terms.
