I would like to inform you of several changes within our Global Listed Real Estate (GLRE) team, as we continue to reshape our business around our commitment to continuous improvement and a high performance-led culture. To achieve this, we are driving proactive change and growing our headcount to 15 dedicated investors.

We are delighted to announce that Jessica Koh will be promoted from Portfolio Manager to Head of Asia Listed Real Estate. Jessica Koh has been an instrumental member of the GLRE team for the last twelve years, based in the Sydney, Singapore, and Hong Kong offices, covering most developed and emerging markets in the Asia Pacific region. We consider Jessica to be a talented analyst and portfolio manager, a skilled allocator of capital and someone who demonstrates strong leadership qualities. She brings to the role 15 years' of real estate experience in both listed and direct markets and will be responsible for managing the team in Asia.

Collectively, these new hires will increase the European and Australian GLRE teams to three people each.

As part of this restructure, we are currently well progressed in recruiting a second analyst/portfolio manager to join the Hong Kong team, reporting into Jessica and rounding the team out to three investors.

We believe this team build-out reflects the sheer size and depth of opportunity of the broader global listed real estate market, and what we see as exceptional opportunities to deliver outperformance for you; our clients and partners.

Charles Wong, currently Head of Asian Listed Real Estate, will leave the business. Charles has been with AMP Capital for 11 years' and we thank him for his commitment and tenure over that time.

We would like to thank you for your ongoing support throughout this period of change. We have made great in-roads in reshaping our business to focus on delivering stronger, risk-adjusted returns and on supporting your listed real estate investment needs. Ensuring we continue to strengthen and re-invest in the investment team is in both direct response to your feedback and our long-term strategic thinking. Looking ahead, we believe we have now pivoted the team to continue to deliver strong risk-adjusted returns, aimed at exceeding client investment objectives and we are excited about the opportunities that we see in these markets.
