What is the purpose of this update?

Description of this fund

Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund on the first day of the month following the funds receipt of its first contribution, 1 November 2020, and did not make any further contributions. At the end of the period to 31 December 2020, Anthony received a return after fund charges were deducted of \$1,240 (that is 12.40% of his initial \$10,000). This gives Anthony a total return after tax of \$1,247 for the period.


What does the fund invest in?

Notes

- i. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years.
