What is the purpose of this update?

This document tells you how the InvestNow Hunter Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

Objective: to perform broadly in line with the return of its investment benchmark before fees and tax over the long-term.

Strategy: aims for high long-run returns by investing in a diversified portfolio weighted towards growth assets but with some income asset exposure.

Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund on the first day of the month following the funds receipt of its first contribution, 1 November 2020, and did not make any further contributions. At the end of the period to 31 December 2020, Anthony received a return after fund charges were deducted of \$540 (that is 5.40% of his initial \$10,000). This gives Anthony a total return after tax of \$521 for the period.



What does the fund invest in?


This shows the types of assets that the fund invests in.

Notes

- i. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility. Market index returns have been used until 31 October 2020 and fund returns thereafter.
- ii. As the InvestNow Hunter Growth Fund only started accepting contributions on 14 September 2020 historical fee information is not available. The fund charges represent our best estimates of the fees and expenses that will be charged to the fund. These have been estimated using information provided by the underlying fund manager and by reference to the underlying fund's disclosure documents.
