# What is the purpose of this update?

# Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund on the first day of the month following the funds receipt of its first contribution, 1 November 2020, and did not make any further contributions. At the end of the period to 31 December 2020, Anthony received a return after fund charges were deducted of \$745 (that is 7.45% of his initial \$10,000). This gives Anthony a total return after tax of \$725 for the period.


# What does the fund invest in?

#### Notes

- i. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility. Market index returns have been used until 31 October 2020 and fund returns thereafter.
- ii. As the InvestNow T. Rowe Price Global Equity Growth Fund only started accepting contributions on 5 October 2020 historical fee information is not available. The fund charges represent our best estimates of the fees and expenses that will be charged to the fund. These have been estimated using information provided by the underlying fund manager and by reference to the underlying fund's disclosure documents.
