What is the purpose of this update?

This document tells you how the InvestNow Harbour Australasian Equity Focus Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Implemented Investment Solutions Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: aims to deliver medium to long term capital growth through investing in quality businesses with strong growth prospects.

Strategy: provides exposure to a portfolio of actively managed New Zealand and Australian listed equities. The underlying fund is a high conviction fund where the portfolio will consist of companies Harbour have researched and have a high belief will perform over the medium to longer-term.

Example of how this applies to an investor

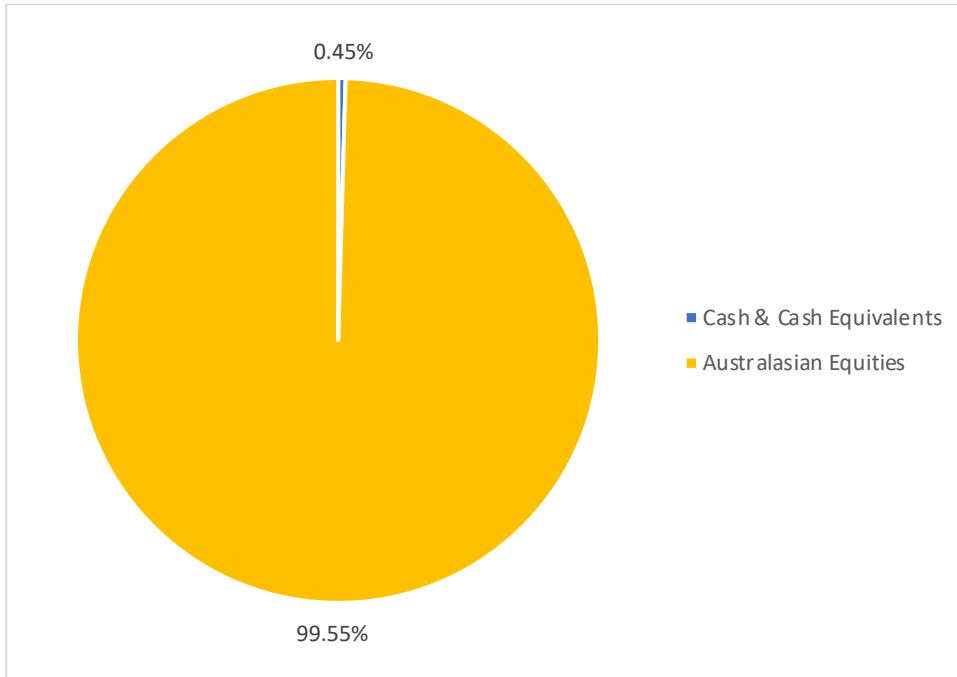
Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund on the first day of the month following the funds receipt of its first contribution, 1 November 2020, and did not make any further contributions. At the end of the period to 31 March 2021, Anthony received a return after fund charges were deducted of \$931 (that is 9.31% of his initial \$10,000). This gives Anthony a total return after tax of \$933 for the period.

What does the fund invest in?

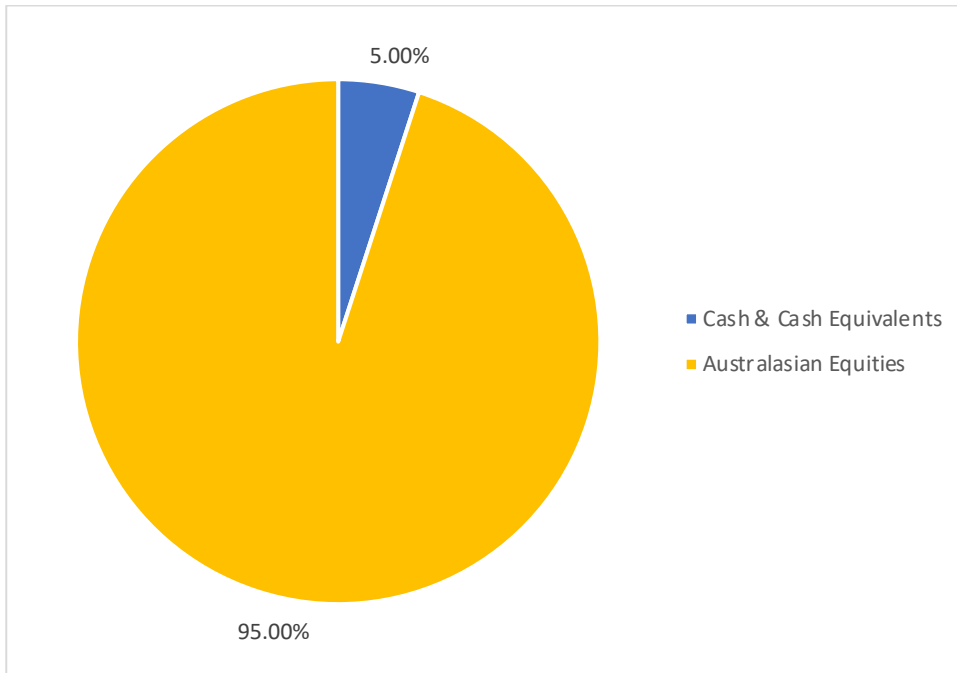
This shows the types of assets that the fund invests in.

Notes

- i. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years.
