What is the purpose of this update?

This document tells you how the InvestNow T. Rowe Price Global Equity Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

Objective: aims to provide long-term capital appreciation.

Strategy: provides exposure to an actively managed global shares fund that invests primarily in a portfolio of securities of companies which are traded, listed or due to be listed, on recognised exchanges and/or markets throughout the world.

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund on the first day of the month following the funds receipt of its first contribution, 1 November 2020, and did not make any further contributions. At the end of the period to 31 March 2021, Anthony received a return after fund charges were deducted of \$1,274 (that is 12.74% of his initial \$10,000). This gives Anthony a total return after tax of \$1,225 for the period.




What does the fund invest in?

Notes
