What is the purpose of this update?

This is a replacement fund update. It replaces the previous fund update for the quarter ending 31 March 2021, first made publicly available on 30 April 2021. We identified the market index annual return was incorrect. This has been corrected in this fund update and resulted in a change to the "How has the fund performed?" section.

This document tells you how the InvestNow Mint Diversified Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Implemented Investment Solutions Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: aims to deliver returns in excess of the Consumers Price Index (CPI) by 4.5% per annum, before fees, over the medium to long-term.

Strategy: provides exposure to a diversified fund that invests primarily in New Zealand and international equities, but will also hold cash and fixed interest securities.

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund on the first day of the month following the funds receipt of its first contribution, 1 November 2020, and did not make any further contributions. At the end of the period to 31 March 2021, Anthony received a return after fund charges were deducted of \$1,118 (that is 11.18% of his initial \$10,000). This gives Anthony a total return after tax of \$999 for the period.




What does the fund invest in?

Notes

- i. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. - ii. As the InvestNow Mint Diversified Growth Fund only started accepting contributions on 5 October 2020 historical fee information is not available.
