What is the purpose of this update?

This document tells you how the InvestNow Pathfinder Ethical Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

Objective: focuses on ethical investing to achieve medium to high returns with a higher risk focus.

Strategy: provides exposure to a diversified ethical portfolio with a higher exposure to growth assets and a lower exposure to income assets.

Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund on the first day of the month following the funds receipt of its first contribution, 1 June 2021, and did not make any further contributions. At the end of the period to 30 June 2021, Anthony received a return after fund charges were deducted of \$299 (that is 2.99% of his initial \$10,000). This gives Anthony a total return after tax of \$293 for the period.



What does the fund invest in?


This shows the types of assets that the fund invests in.

The fund's target currency hedging level is 50% (actual hedging level was was 21.72% at the quarter end) of the foreign currency exposure (this will change over time). Total unhedged foreign exposure is 35.65% of the net asset value of the fund at 30 June 2021 (this will change over time).

Notes

- i. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. - ii. As the InvestNow Pathfinder Ethical Growth Fund only started accepting contributions on 19 April 2021 historical fee information is not available.
