# What is the purpose of this update?

This document tells you how the InvestNow Harbour Australasian Equity Focus Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. #### **Description of this fund**

**Objective:** aims to deliver medium to long term capital growth through investing in quality businesses with strong growth prospects.

**Strategy:** provides exposure to a portfolio of actively managed New Zealand and Australian listed equities. The underlying fund is a high conviction fund where the portfolio will consist of companies Harbour have researched and have a high belief will perform over the medium to longer-term.

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund on the first day of the month following the funds receipt of its first contribution, 1 November 2020, and did not make any further contributions. At the end of the period to 30 June 2021, Anthony received a return after fund charges were deducted of \$1,546 (that is 15.46% of his initial \$10,000). This gives Anthony a total return after tax of \$1,534 for the period.



### What does the fund invest in?


This shows the types of assets that the fund invests in.

#### **Notes**

- i. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. - ii. As the InvestNow Harbour Australasian Equity Focus Fund only started accepting contributions on 5 October 2020 historical fee information is not available. These have been estimated using information provided by the underlying fund manager and by reference to the underlying fund's disclosure documents.
