What is the purpose of this update?

This document tells you how the InvestNow AMP Capital Global Property Securities Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Implemented Investment Solutions Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: to provide a gross return above the FTSE EPRA/ NAREIT Developed Total Return Index with net dividends reinvested, fully hedged to New Zealand dollars, on a rolling three year basis.

Strategy: provides exposure to an actively managed fund that invests in a global portfolio of property securities listed on stock exchanges around the world. Environmental, Social and Governance characteristics are integrated into the investment process.

Example of how this applies to an investor

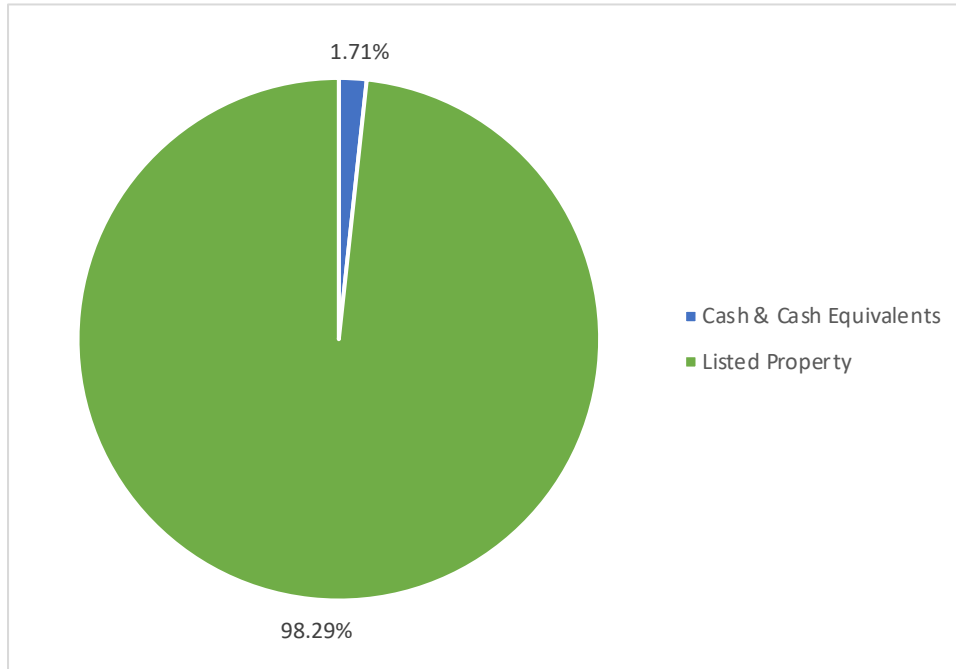
Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund on the first day of the month following the funds receipt of its first contribution, 1 November 2020, and did not make any further contributions. At the end of the period to 30 June 2021, Anthony received a return after fund charges were deducted of \$3,059 (that is 30.59% of his initial \$10,000). This gives Anthony a total return after tax of \$2,979 for the period.

What does the fund invest in?

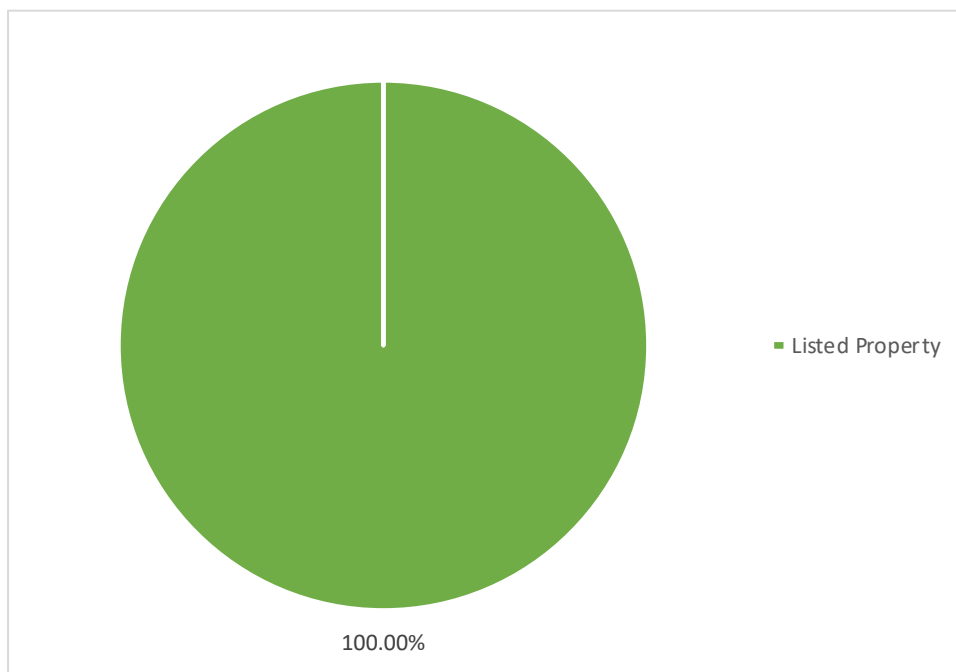
This shows the types of assets that the fund invests in.

Notes

- i. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. - ii. As the InvestNow AMP Capital Global Property Securities Fund only started accepting contributions on 5 October 2020 historical fee information is not available. These have been estimated using information provided by the underlying fund manager and by reference to the underlying fund's disclosure documents.
