What is the purpose of this update?

This document tells you how the InvestNow Fisher Funds Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

Objective: aims to grow your investment over the long term by investing mainly in growth assets.

Strategy: provides exposure to a diversified fund that is best suited to a long-term investor who can tolerate volatility of returns in the expectation of potential higher returns, and has time on their side.

Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund on the first day of the month following the funds receipt of its first contribution, 1 August 2021, and did not make any further contributions. At the end of the period to 30 September 2021, Anthony received a return after fund charges were deducted of \$114 (that is 1.14% of his initial \$10,000). This gives Anthony a total return after tax of \$111 for the period.

This shows the types of assets that the fund invests in.


Actual investment mix



The fund targets a position of being: 100% hedged into NZD for international fixed interest but was 100.2% hedged at quarter end; 100% hedged into NZD for Australasian equities but was 87.7% hedged at quarter end; 70% hedged into NZD for international equities but was 72.1% hedged at quarter end; and 70% hedged into NZD for property and infrastructure assets but was 71.2% hedged at quarter end.

Notes

- i. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. - ii. As the InvestNow Fisher Funds Growth Fund only started accepting contributions on 5 July 2021 historical fee information is not available. These have been estimated using information provided by the underlying fund manager and by reference to the underlying fund's disclosure documents.
