### What is the purpose of this update?

This document tells you how the InvestNow Harbour NZ Core Fixed Interest Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Implemented Investment Solutions Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

**Objective:** aims to outperform the Bloomberg NZBond Composite 0+ Yr Index by 100 basis points per annum over a rolling three year period.

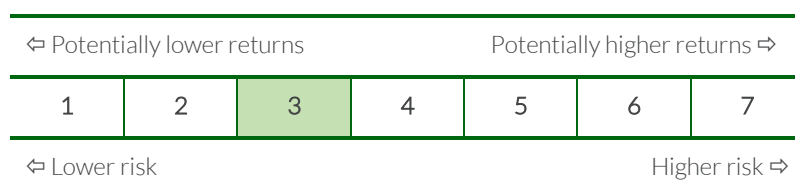
**Strategy:** provides exposure to an actively managed investment grade portfolio that invests mainly in New Zealand Government bond and corporate bond fixed interest securities.

### What are the risks of investing?

Risk indicator for the InvestNow Harbour NZ Core Fixed Interest Fund<sup>1</sup>.



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

## Example of how this applies to an investor

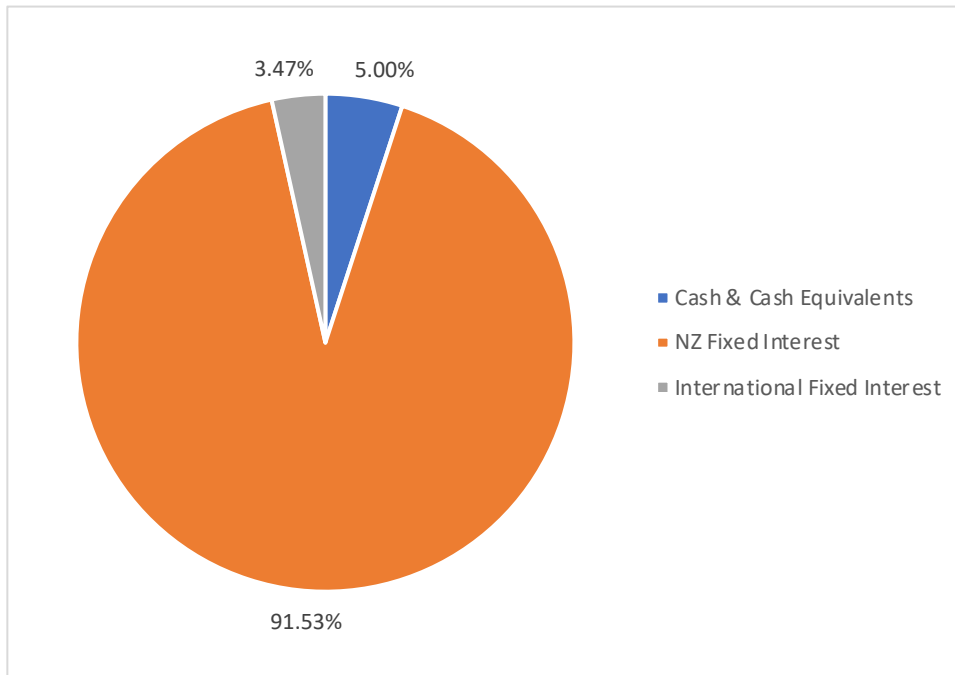
Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund on the first day of the month following the fund's receipt of its first contribution, 1 November 2020, and did not make any further contributions. At the end of the period to 30 September 2021, Anthony incurred a loss after fund charges were deducted of -\$457 (that is -4.57% of his initial \$10,000). This gives Anthony a total loss after tax of -\$329 for the period.

### What does the fund invest in?

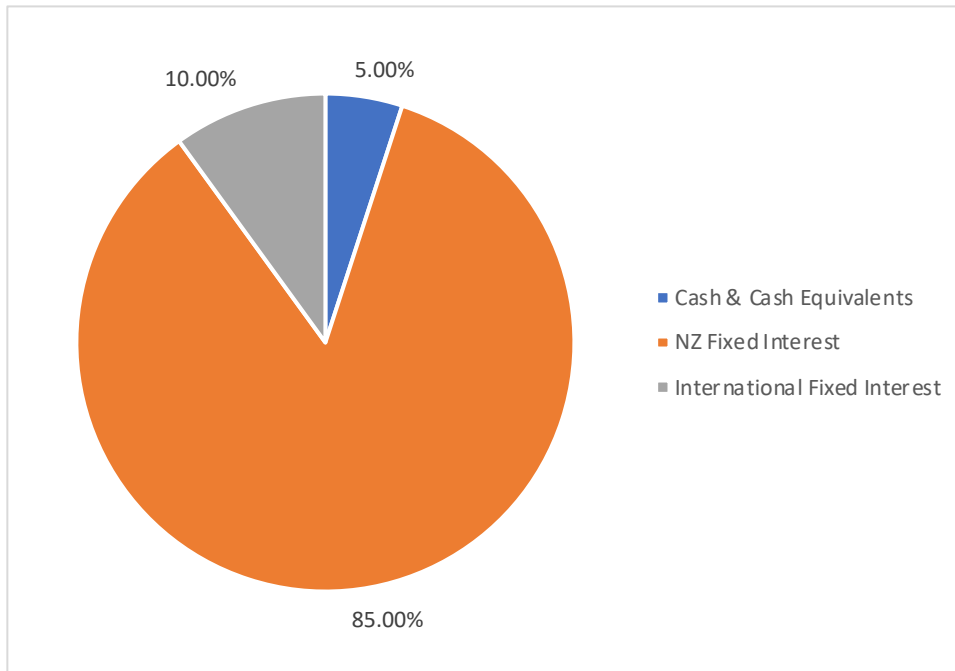
This shows the types of assets that the fund invests in.

## Notes

- A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years.
