What is the purpose of this update?

This document tells you how the InvestNow Milford Active Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Implemented Investment Solutions Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: aims to provide annual returns of 10% after the base fund fee, but before tax and before the performance fee over the minimum recommended investment timeframe.

Strategy: provides exposure to a diversified fund that primarily invests in shares, with a moderate allocation to fixed interest securities

Example of how this applies to an investor

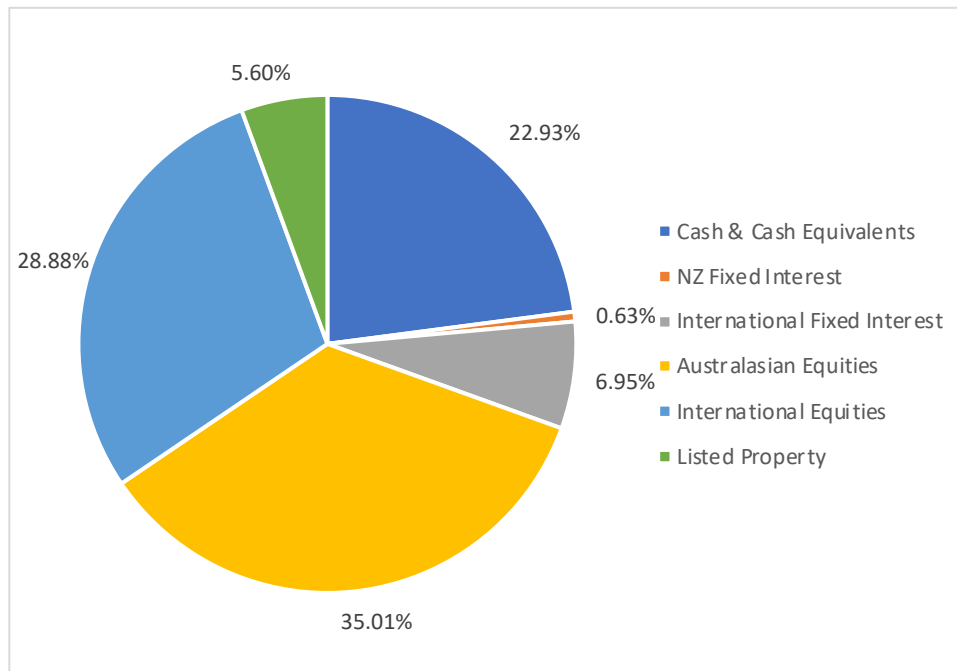
Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund on the first day of the month following the fund's receipt of its first contribution, 1 August 2021, and did not make any further contributions. At the end of the period to 30 September 2021, Anthony received a return after fund charges were deducted of \$240 (that is 2.40% of his initial \$10,000). This gives Anthony a total return after tax of \$226 for the period.

What does the fund invest in?

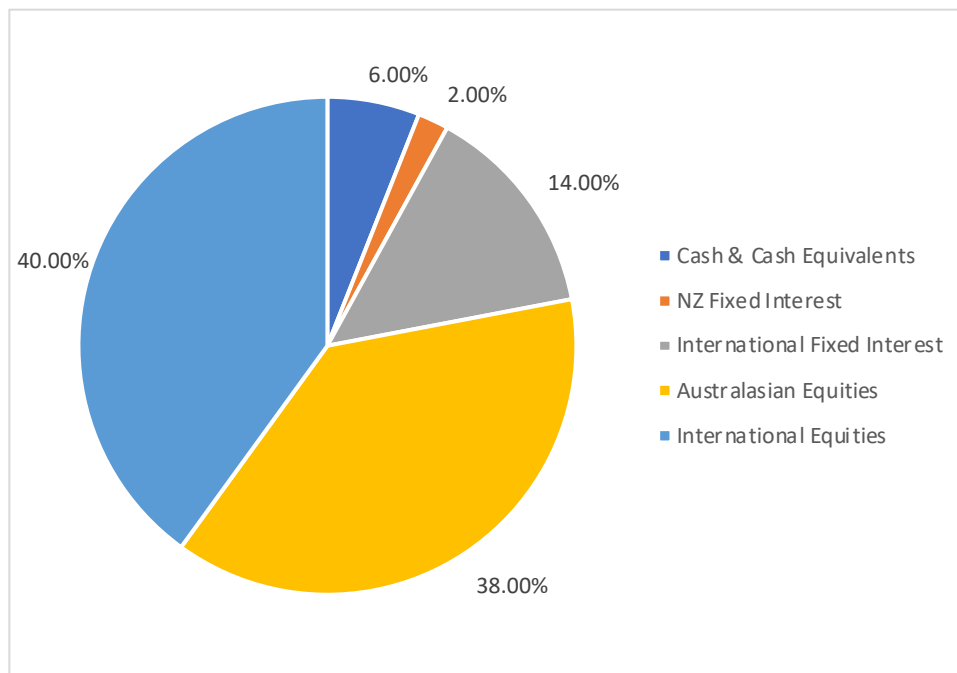
This shows the types of assets that the fund invests in.

Notes

- A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility. Market index returns have been used until 31 July 2021 and fund returns thereafter.
- As the InvestNow Milford Active Growth Fund only started accepting contributions on 5 July 2021 historical fee information is not available. The fund charges represent our best estimates of the fees and expenses that will be charged to the fund. These have been estimated using information provided by the underlying fund manager and by reference to the underlying fund's disclosure documents.
