What is the purpose of this update?

This document tells you how the InvestNow Russell Investments Hedged Global Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

Objective: aims to outperform the MSCI ACWI Index – 100% Hedged to NZD - Net, before costs and tax, over the long term (3 years plus).

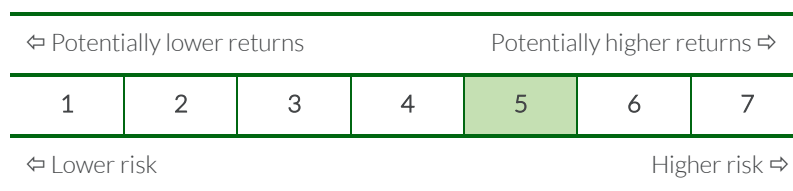
Strategy: provides exposure to an international shares fund that is actively managed using a multi-manager approach. The underlying fund targets being fully hedged back to New Zealand dollars.

What are the risks of investing?

Risk indicator for the InvestNow Russell Investments Hedged Global Shares Fund¹.

Example of how this applies to an investor

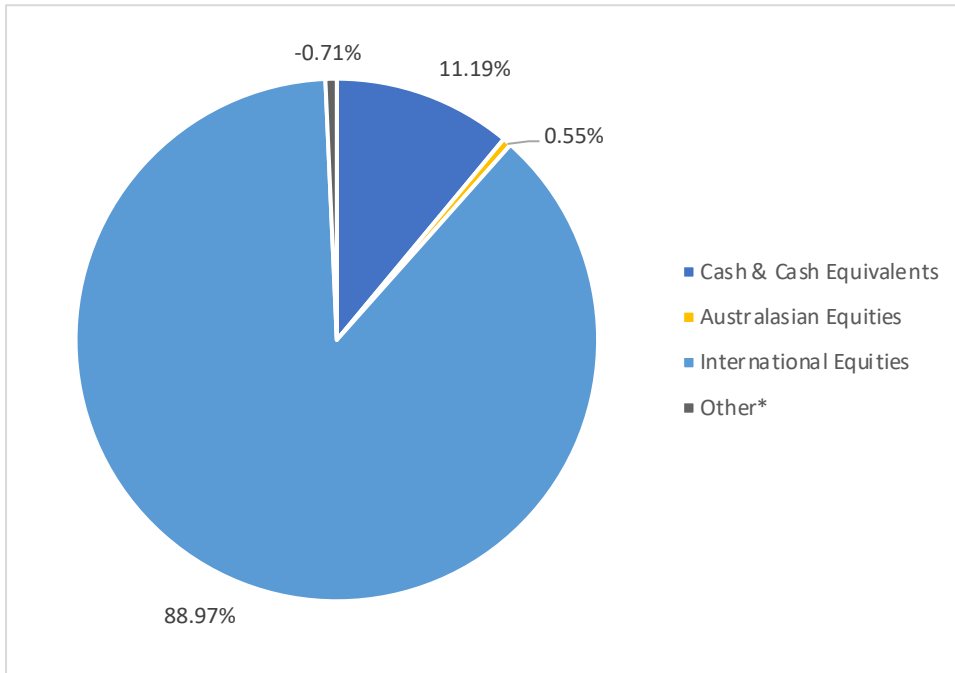
Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund on the first day of the month following the fund's receipt of its first contribution, 1 November 2020, and did not make any further contributions. At the end of the period to 30 September 2021, Anthony received a return after fund charges were deducted of \$3,209 (that is 32.09% of his initial \$10,000). This gives Anthony a total return after tax of \$3,088 for the period.

What does the fund invest in?

This shows the types of assets that the fund invests in.

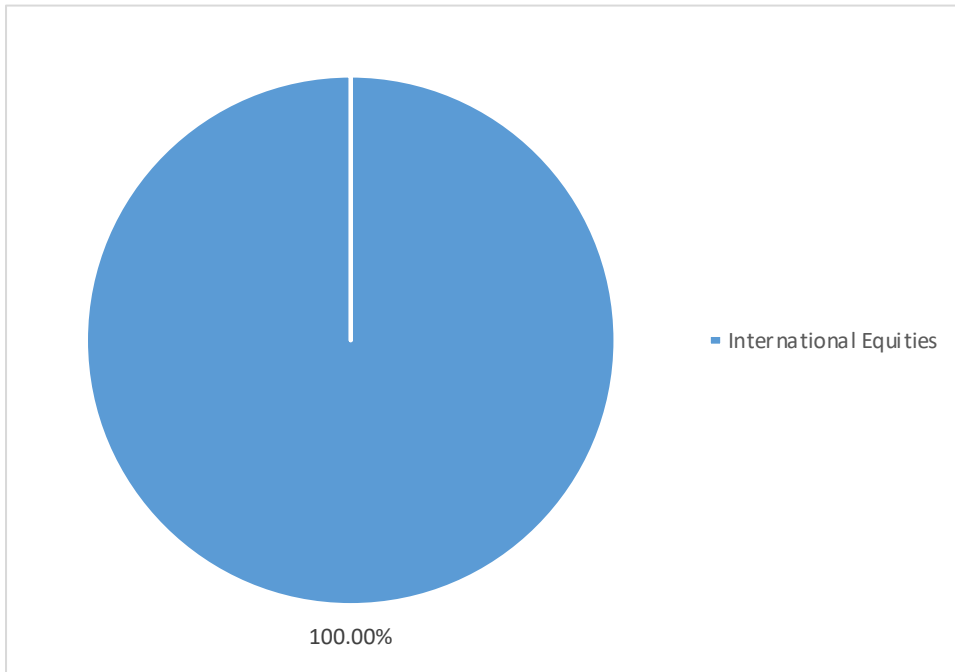
Actual investment mix



The fund targets a position of being fully hedged back to New Zealand Dollars. Due to active currency management by the underlying managers, there will generally be some foreign currency exposure.

Notes

- i. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. - ii. As the InvestNow Russell Investments Hedged Global Shares Fund only started accepting contributions on 5 October 2020 historical fee information is not available. These have been estimated using information provided by the underlying fund manager and by reference to the underlying fund's disclosure documents.
