Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund on the first day of the month following the funds receipt of its first contribution, 1 August 2021, and did not make any further contributions. At the end of the period to 30 September 2021, Anthony received a return after fund charges were deducted of \$80 (that is 0.80% of his initial \$10,000). This gives Anthony a total return after tax of \$76 for the period.



What does the fund invest in?


This shows the types of assets that the fund invests in.

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 64%. The actual hedging level can be anywhere in the 0% - 120% range. As at 30 September 2021, 64.2% of the fund's foreign currency exposure was hedged.

Notes

- i. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. - ii. As the InvestNow Smartshares Growth Fund only started accepting contributions on 5 July 2021 historical fee information is not available. The fund charges represent our best estimates of the fees and expenses that will be charged to the fund. These have been estimated using information provided by the underlying fund manager and by reference to the underlying fund's disclosure documents.
