

Fund Update

This revised Fund Update was first made publicly available on 3 December 2021. It replaces the Fund Update published on 29 October 2021. The changes made relate to annual returns and investor example.

What is the purpose of this update?

This document tells you how the InvestNow Foundation Series Balanced Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Implemented Investment Solutions Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: to perform broadly in line with the return of its investment benchmark before fees and tax over the long-term.

Strategy: aims for mid-range long-run returns by investing in a diversified portfolio with a balance of income and growth assets.

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year Anthony received a return after fund charges were deducted of \$1,180 (that is 11.80% of his initial \$10,000). This gives Anthony a total return after tax of \$1,125 for the year.



What does the fund invest in?


This shows the types of assets that the fund invests in.

Notes
