#### What is the purpose of this update?

This document tells you how the InvestNow Harbour T. Rowe Price Global Equity Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. #### Description of this fund

## Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year Anthony received a return after fund charges were deducted of \$1,519 (that is 15.19% of his initial \$10,000). This gives Anthony a total return after tax of \$1,400 for the period.



## What does the fund invest in?


This shows the types of assets that the fund invests in.

#### Notes

These have been estimated using information provided by the underlying fund manager and by reference to the underlying fund's disclosure documents.
