What is the purpose of this update?

This document tells you how the InvestNow Milford Conservative Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

Objective: to provide moderate returns and protect capital over the minimum recommended investment timeframe.

Strategy: provides exposure to a diversified fund that primarily invests in fixed interest securities, with a moderate allocation to shares.

Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year Anthony received a return after fund charges were deducted of \$156 (that is 1.56% of his initial \$10,000). This gives Anthony a total return after tax of \$190 for the period.



What does the fund invest in?


This shows the types of assets that the fund invests in.
