What is the purpose of this update?

This document tells you how the InvestNow Mint Diversified Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Implemented Investment Solutions Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: aims to deliver returns in excess of the Consumers Price Index (CPI) by 4.5% per annum, before fees, over the medium to long-term.

Strategy: provides exposure to a diversified fund that invests primarily in New Zealand and international equities, but will also hold cash and fixed interest securities.

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year Anthony received a return after fund charges were deducted of \$1,791 (that is 17.91% of his initial \$10,000). This gives Anthony a total return after tax of \$1,791 for the period.



What does the fund invest in?


This shows the types of assets that the fund invests in.

Notes
