What is the purpose of this update?

This document tells you how the InvestNow Pathfinder Ethical Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Implemented Investment Solutions Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: focuses on ethical investing to achieve medium to high returns with a higher risk focus.

Strategy: provides exposure to a diversified ethical portfolio with a higher exposure to growth assets and a lower exposure to income assets.

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund on the first day of the month following the funds receipt of its first contribution, 1 June 2021, and did not make any further contributions. At the end of the period to 31 December 2021, Anthony received a return after fund charges were deducted of \$832 (that is 8.32% of his initial \$10,000). This gives Anthony a total return after tax of \$328 for the period.



What does the fund invest in?


This shows the types of assets that the fund invests in.

The target currency hedging is 50% of non-NZD equity exposure and 100% of non-NZD fixed interest exposure (actual hedging level was 50.65% at the quarter end (this will change over time)). Total unhedged foreign exposure is 28.02% of the net asset value of the fund at 31 December 2021 (this will change over time).

Other refers to private equities/ loans and unlisted properties.

Notes

- A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility. Market index returns have been used until 31 May 2021 and fund returns thereafter.
- ii. As the InvestNow Pathfinder Ethical Growth Fund only started accepting contributions on 19 April 2021 historical fee information is not available. The fund charges represent our best estimates of the fees and expenses that will be charged to the fund. These have been estimated using information provided by the underlying fund manager and by reference to the underlying fund's disclosure documents.
