What is the purpose of this update?

This document tells you how the InvestNow Smartshares Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

Objective: designed for investors that want a growth investment option.

Strategy: provides exposure to a diversified fund that invests mainly in growth assets.

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Example of how this applies to an investor

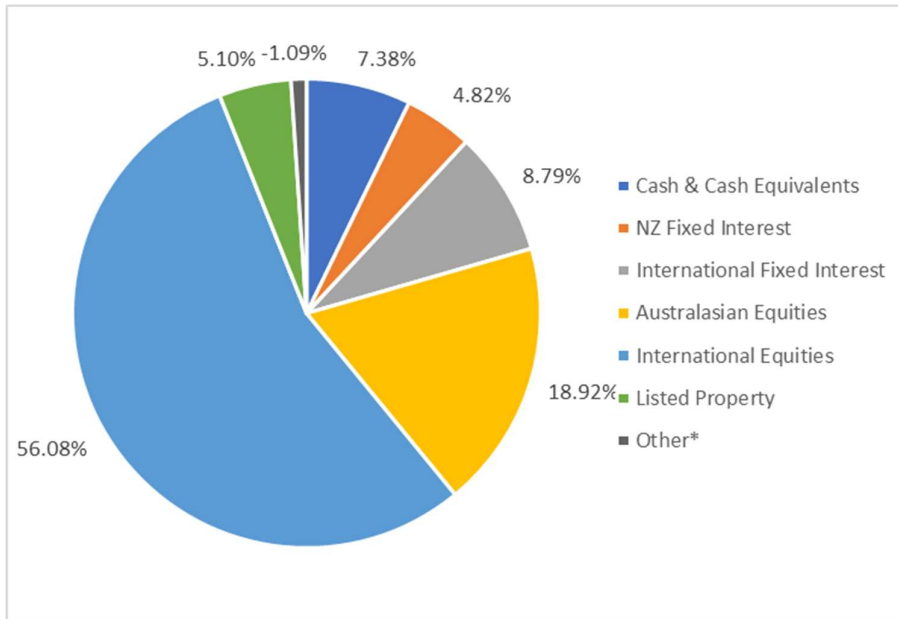
Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund on the first day of the month following the fund's receipt of its first contribution, 1 August 2021, and did not make any further contributions. At the end of the period to 31 December 2021, Anthony received a return after fund charges were deducted of \$417 (that is 4.17% of his initial \$10,000). This gives Anthony a total return after tax of \$405 for the period.

What does the fund invest in?

This shows the types of assets that the fund invests in.

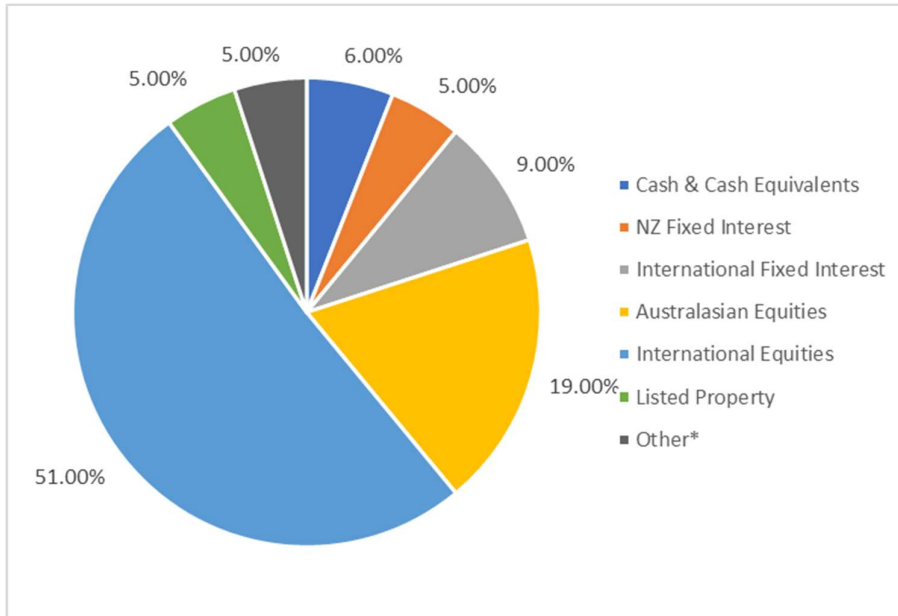
Actual investment mix



The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 67%. The actual hedging level can be anywhere in the 0% - 120% range. As at 31 December 2021, 64.8% of the fund's foreign currency exposure was hedged.

Other includes fund expenses, tax expenses and outstanding settlements.

Notes

- A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility. Market index returns have been used until 31 July 2021 and fund returns thereafter.
- As the InvestNow Smartshares Growth Fund only started accepting contributions on 5 July 2021 historical fee information is not available. The fund charges represent our best estimates of the fees and expenses that will be charged to the fund. These have been estimated using information provided by the underlying fund manager and by reference to the underlying fund's disclosure documents.
