What is the purpose of this update?

This document tells you how the InvestNow Smartshares Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund on the first day of the month following the funds receipt of its first contribution, 1 August 2021, and did not make any further contributions. At the end of the period to 31 December 2021, Anthony received a return after fund charges were deducted of \$417 (that is 4.17% of his initial \$10,000). This gives Anthony a total return after tax of \$405 for the period.

This shows the types of assets that the fund invests in.


Actual investment mix



The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 67%. The actual hedging level can be anywhere in the 0% - 120% range. As at 31 December 2021, 64.8% of the fund's foreign currency exposure was hedged.

Other includes fund expenses, tax expenses and outstanding settlements.
