# What is the purpose of this update?

This document tells you how the InvestNow Ethical Leaders Hedged Global Fixed Interest Index Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Implemented Investment Solutions Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

**Objective:** aims to provide a return that closely matches the return of the Bloomberg Barclays MSCI Global Aggregate SRI Select ex-Fossil Fuels Index, fully hedged to the New Zealand dollar.

Strategy: provides exposure to a passively managed international fixed interest portfolio.

# What are the risks of investing?

#### Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year Anthony incurred a loss after fund charges were deducted of \$210 (that is -2.10% of his initial \$10,000). This gives Anthony a total loss after tax of \$152 for the period.



# What does the fund invest in?


This shows the types of assets that the fund invests in.

## Notes
