## What is the purpose of this update?

This document tells you how the InvestNow Foundation Series Balanced Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Implemented Investment Solutions Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

**Objective:** to perform broadly in line with the return of its investment benchmark before fees and tax over the long-term.

**Strategy:** aims for mid-range long-run returns by investing in a diversified portfolio with a balance of income and growth assets.

### Example of how this applies to an investor

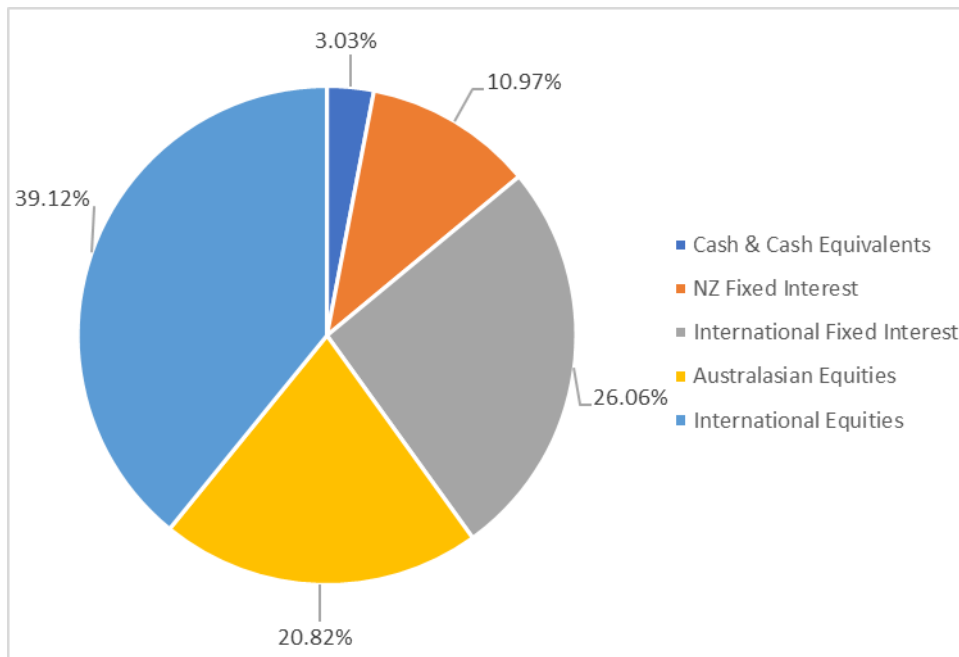
Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year Anthony received a return after fund charges were deducted of \$994 (that is 9.94% of his initial \$10,000). This gives Anthony a total return after tax of \$949 for the period.

### What does the fund invest in?

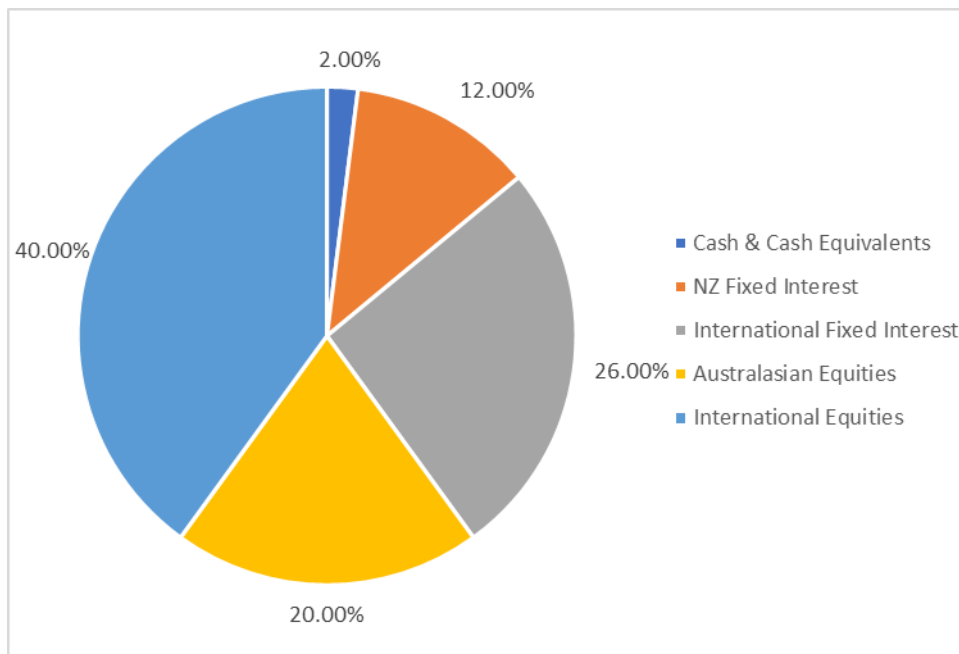
This shows the types of assets that the fund invests in.

## Notes

- i. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. - ii. As the InvestNow Foundation Series Balanced Fund only started accepting contributions on 14 September 2020 historical fee information is not available. These have been estimated using information provided by the underlying fund manager and by reference to the underlying fund's disclosure documents.
