## What is the purpose of this update?

This document tells you how the InvestNow Smartshares Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Implemented Investment Solutions Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

**Objective:** designed for investors that want a growth investment option.

**Strategy:** provides exposure to a diversified fund that invests mainly in growth assets.

### Example of how this applies to an investor

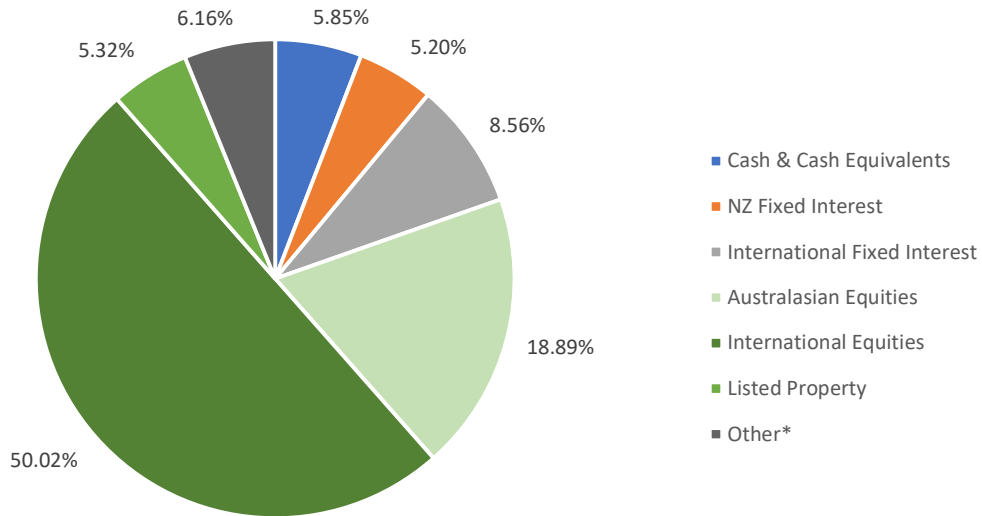
Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund on the first day of the month following the fund's receipt of its first contribution, 1 August 2021, and did not make any further contributions. At the end of the period to 31 March 2022, Anthony received a return after fund charges were deducted of \$33 (that is 0.33% of his initial \$10,000). This gives Anthony a total return after tax of \$69 for the period.

**What does the fund invest in?**

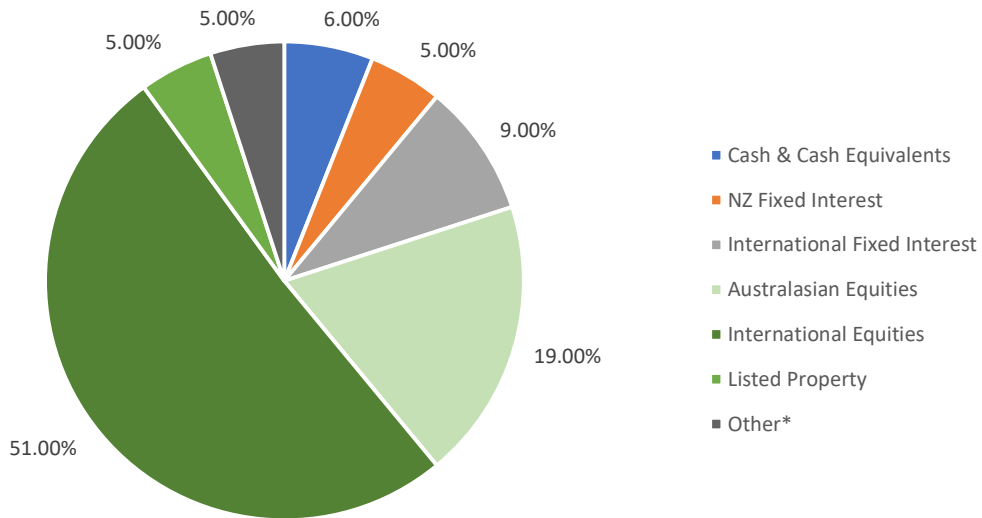
This shows the types of assets that the fund invests in.

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 67%. The actual hedging level can be anywhere in the 0% - 120% range. As at 31 March 2022, 69% of the fund's foreign currency exposure was hedged.

## Notes

- A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. - As the InvestNow Smartshares Growth Fund only started accepting contributions on 5 July 2021 historical fee information is not available. These have been estimated using information provided by the underlying fund manager and by reference to the underlying fund's disclosure documents.
