## What is the purpose of this update?

This document tells you how the InvestNow Antipodes Global Fund - Long has performed and what fees were charged. The document will help you to compare the fund with other funds. Implemented Investment Solutions Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

**Objective:** aims to achieve absolute returns in excess of the MSCI All Country World Net Index in NZ dollars over the investment cycle (typically 3-5 years).

**Strategy:** provides exposure to a diversified portfolio of international shares which is actively managed.

### Example of how this applies to an investor

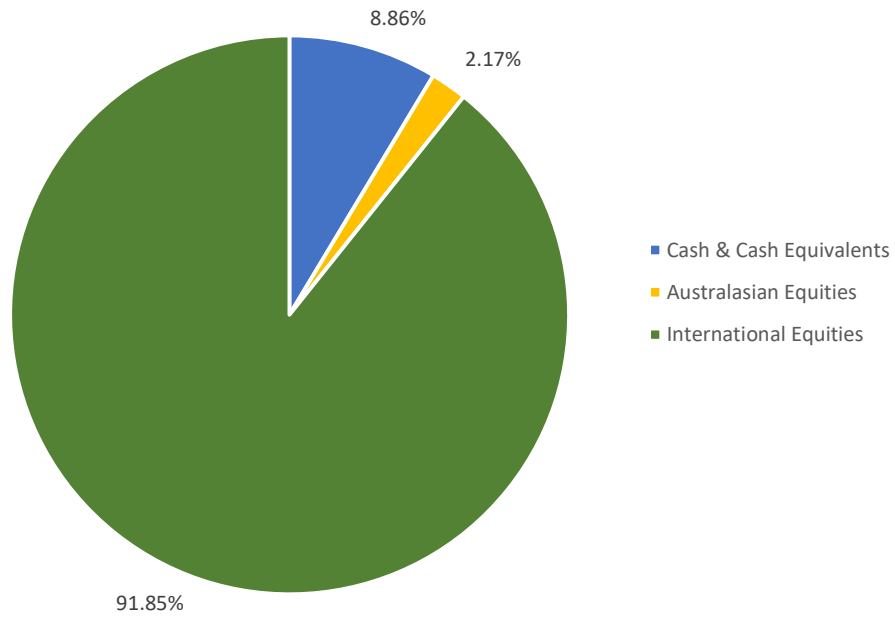
Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund on the first day of the month following the funds receipt of its first contribution, 11 March 2022, and did not make any further contributions. At the end of the period to 31 March 2022, Anthony incurred a loss after fund charges were deducted of \$239 (that is -2.39% of his initial \$10,000). This gives Anthony a total loss after tax of \$229 for the period.

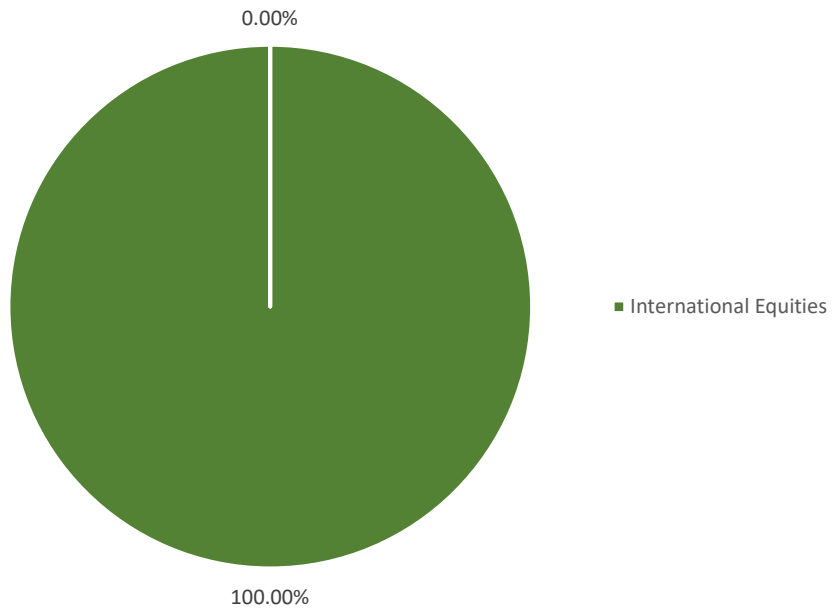
### What does the fund invest in?

## Notes

- i. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years.
