#### What is the purpose of this update?

This document tells you how the InvestNow Castle Point Trans-Tasman Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Implemented Investment Solutions Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

**Objective:** aims to outperform the S&P/NZX 50 Index (incl Imputation Credits) over rolling three-year periods after all fees (and other expenses) but before tax.

**Strategy:** provides exposure to an actively managed portfolio that typically invests in New Zealand and Australian listed companies.

## Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year Anthony incurred a loss after fund charges were deducted of \$314 (that is -3.14% of his initial \$10,000). This gives Anthony a total loss after tax of \$310 for the period.



## What does the fund invest in?


This shows the types of assets that the fund invests in.

## Notes

- A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been

- ii. As the InvestNow Castle Point Trans-Tasman Fund only started accepting contributions on 5 October 2020 historical fee information is not available. These have been estimated using information provided by the underlying fund manager and by reference to the underlying fund's disclosure documents.
