#### What is the purpose of this update?

This document tells you how the InvestNow Australasian Property Index Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Implemented Investment Solutions Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### Description of this fund

**Objective:** to provide a passively managed low tracking error portfolio managed against companies listed on the S&P/NZX All Real Estate (Industry Group) Gross with Imputation Index and the S&P/ASX 200 A-REIT Accumulation Index fully hedged to New Zealand dollars.

Strategy: provides exposure to a passively managed portfolio of Australasian listed property investments.

# What are the risks of investing?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



## How has the fund performed?

The market index return is 60% the S&P/NZX All Real Estate (Industry Group) Gross with Imputation Index and 40% the S&P/ASX 200 A-REIT Accumulation Index fully hedged to New Zealand dollars. # Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year Anthony received a return after fund charges were deducted of \$655 (that is 6.55% of his initial \$10,000). This gives Anthony a total return after tax of \$571 for the period.



# What does the fund invest in?


This shows the types of assets that the fund invests in.

## Notes
