#### What is the purpose of this update?

# Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund when the fund received its first contribution, on 5 July 2021, and did not make any further contributions. At the end of the period, Anthony received a return after fund charges were deducted of \$871 (that is 8.71% of his initial \$10,000). This gives Anthony a total return after tax of \$882 for the period.

This shows the types of assets that the fund invests in.


#### Actual investment mix



The target hedging level is 67%. The actual hedging level can be anywhere in the 0% - 120% range. As at 31 March 2022, 69% of the fund's foreign currency exposure was hedged.

#### Notes

- A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility.

- ii. As the InvestNow Smartshares Growth Fund only started accepting contributions on 5 July 2021 historical fee information is not available. The fund charges represent our best estimates of the fees and expenses that will be charged to the fund. These have been estimated using information provided by the underlying fund manager and by reference to the underlying fund's disclosure documents.
