3. Changes relating to the scheme

The following details material changes to the nature of the Scheme, including changes to the investment objectives and strategies of the investment options offered to Scheme members.

19 April 2021

The InvestNow Mint Australasian Equity Fund reduced its estimated total annual fund charge from 1.36% p.a. to 1.21% p.a.

The InvestNow Mint Diversified Growth Fund reduced its estimated total annual fund charge from 1.36% p.a. to 1.23% p.a.

The InvestNow Mint Diversified Income Fund reduced its estimated total annual fund charge from 1.08% p.a. to 0.95% p.a.

Two new funds were added to the Scheme: the InvestNow Harbour Active Growth Fund and the InvestNow Pathfinder Ethical Growth Fund.

21 June 2021

The InvestNow AMP Capital Ethical Leaders Balanced Fund reduced its estimated total annual fund charge from 1.32% p.a. to 1.27% p.a.

The InvestNow Hedged Global Fixed Interest Index Fund changed its name to the InvestNow Ethical Leaders Hedged Global Fixed Interest Index Fund to reflect a change in the underlying fund name, as well as newly introduced responsible investment criteria. The benchmark for this fund was changed from the Bloomberg Barclays Global Aggregate Index to the Bloomberg Barclays MSCI Global Aggregate SRI Select ex Fossil Fuels Index. The fund increased its estimated total annual fund charge from 0.41% p.a. to 0.48% p.a.

5 July 2021

Three new funds were added to the Scheme: the InvestNow Milford Active Growth Fund, the InvestNow Smartshares Growth Fund and the InvestNow Fisher Funds Growth Fund.

21 July 2021

The Scheme introduced an ability for members to appoint an approved financial advice provider and pay them an agreed ongoing advice and administration fee (applicable only where the member agrees and receives financial advice).

1 September 2021

The InvestNow Harbour Active Growth Fund increased its performance fee estimate from 0.00% p.a. to 0.02% p.a.

17 September 2021

The InvestNow Castle Point 5 Oceans Fund changed its target investment mix (cash and cash equivalents from 11.5% to 10%, international shares from 30% to 29% and other from 4% to 6.5%).

The InvestNow Smartshares Growth Fund changed its target investment mix (cash and cash equivalents from 1% to 6%, NZ fixed interest from 6.5% to 5%, international fixed interest from 12.5% to 9%, Australasian shares from 20% to 19%, international shares from 52.5% to 51%, listed property from 7.5% to 5% and other from 0% to 5%).

20 September 2021

The InvestNow NZ Shares Fund reduced its estimated total annual fund charge from 0.33% p.a. to 0.31% p.a.

The InvestNow Ethical Leaders Hedged Global Fixed Interest Index Fund reduced its estimated total annual fund charge from 0.48% p.a. to 0.42% p.a.

The InvestNow Australasian Property Index Fund reduced its estimated total annual fund charge from 0.45% p.a. to 0.43% p.a.

The InvestNow All Country Global Shares Index Fund increased its estimated total annual fund charge from 0.40% p.a. to 0.45% p.a.

30 September 2021

The InvestNow Hunter Balanced Fund and InvestNow Hunter Growth Fund changed their names to the InvestNow Foundation Series Balanced Fund and InvestNow Foundation Series Growth Fund to reflect a change in the underlying fund names, as well as a change in the underlying fund manager from Hunter Investment Manager to InvestNow Saving and Investment Service.

27 October 2021

The InvestNow Pathfinder Ethical Growth Fund increased its estimated total annual fund charge from 1.45% p.a. to 1.47% p.a.

The InvestNow Pathfinder Ethical Growth Fund changed its target investment mix (cash and cash equivalents from 6% to 8.7%, NZ fixed interest from 10% to 7.2%, international fixed interest from 10% to 9.2%, Australasian shares from 40% to 22.5%, international shares from 30% to 41.4%, listed property from 5% to 6% and other from 0% to 5%). The benchmark for this fund was changed from a composite index of the underlying asset classes to the Morningstar Target Allocation Index – Growth Multisector for New Zealand.

2 November 2021

The InvestNow AMP Capital NZ Cash Fund reduced its estimated total annual fund charge from 0.27% p.a. to 0.26% p.a.

The InvestNow Russell Investments NZ Fixed Interest Fund reduced its estimated total annual fund charge from 0.76% p.a. to 0.49% p.a.

The InvestNow Russell Investments Global Fixed Interest Fund reduced its estimated total annual fund charge from 0.78% p.a. to 0.59% p.a.

The InvestNow Russell Investments Global Shares Fund reduced its estimated total annual fund charge from 1.50% p.a. to 0.98% p.a.

The InvestNow Russell Investments Hedged Global Shares Fund reduced its estimated total annual fund charge from 1.53% p.a. to 1.01% p.a.

18 November 2021

The InvestNow T.Rowe Price Global Equity Growth Fund changed its name to the InvestNow Harbour T.Rowe Price Global Equity Fund to reflect a change in the underlying fund name.

Two new funds were added to the Scheme: the InvestNow Te Ahumairangi Global Equity Fund and the InvestNow Antipodes Global Fund – Long.

6 December 2021

The InvestNow Russell Investments Global Shares Fund reduced its estimated total annual fund charge from 0.98% p.a. to 0.89% p.a.

The InvestNow Russell Investments Hedged Global Shares Fund reduced its estimated total annual fund charge from 1.01% p.a. to 0.92% p.a.

25 January 2022

The InvestNow Harbour Active Growth Fund increased its performance fee estimate from 0.02% p.a. to 0.19% p.a. based on the fund's underlying funds' performance fee estimate.

The InvestNow Fisher Funds Growth Fund changed its target investment mix (cash and cash equivalents from 5% to 1%, NZ fixed interest from 6% to 11%, international fixed interest from 9% to 7%, Australasian shares from 29% to 25% and international shares 42% to 47%).

One new fund was added to the Scheme: the InvestNow Fisher Funds Conservative Fund.

10 February 2022

The InvestNow Foundation Series Balanced Fund and Foundation Series Growth Fund changed their hedging strategy with both funds hedging 50% of their international equity exposure back to New Zealand dollars (previously all international equity exposure for both funds was unhedged).

Other than described above, there were no other material changes to the governing documents, SIPO, management of the Scheme or terms of the offer of the managed investment products over the accounting period.

There were no related party transactions entered into during the accounting period that were not on arm's-length terms.

Manager

Implemented Investment Solutions was the manager of the Scheme throughout the accounting period. Elizabeth Maguire ceased appointment as a board member on 31st October 2021. Gareth Fleming was appointed as a board member on 1st November 2021. There were no other changes to directors and key personnel throughout the accounting period. There was no change in control of the manager during the accounting period.

Supervisor

Public Trust was the supervisor of the Scheme throughout the accounting period. Public Trust does not have directors pursuant to the Companies Act 1993 but has board members pursuant to the Public Trust Act 2001. During the Year, the supervisor had no board changes.

Administration manager, investment manager, securities registrar and custodian No changes occurred to the Scheme's administration manager, investment manager, registrar or custodian throughout the accounting period.

<u>Auditor</u>

KPMG was the auditor of the Scheme throughout the accounting period.
