What is the purpose of this update?

This document tells you how the InvestNow Mint Australasian Equity Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Implemented Investment Solutions Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: aims to provide investors with superior returns with lower risk than the S&P/NZX 50 Gross Index over the medium to long-term.

Strategy: provides exposure to an actively managed portfolio that typically invests in New Zealand and Australian listed equities.

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



How has the fund performed?

Annual Return Graph

Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year Anthony incurred a loss after fund charges were deducted of \$1,882 (that is -18.82% of his initial \$10,000). This gives Anthony a total loss after tax of \$1,909 for the period.

This shows the types of assets that the fund invests in.


Actual investment mix



The actual investment mix incorporates the notional exposure value of equity derivatives and credit default swaps, where applicable. These may increase or decrease the reported Cash and Cash Equivalents.

The fund has 10% of its assets denominated in foreign currencies of which 95% was hedged to NZD.
