What is the purpose of this update?

This document tells you how the InvestNow Pathfinder Ethical Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Implemented Investment Solutions Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: focuses on ethical investing to achieve medium to high returns with a higher risk focus.

Strategy: provides exposure to a diversified ethical portfolio with a higher exposure to growth assets and a lower exposure to income assets.

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

How has the fund performed?

What fees are investors charged?

Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term. Anthony had \$10,000 in the fund when the fund received its first contribution, on 19 April 2021, and did not make any further contributions. At the end of the year Anthony incurred a loss after fund charges were deducted of \$1,153 (that is -11.53% of his initial \$10,000). This gives Anthony a total loss after tax of \$1,096 for the period.

This shows the types of assets that the fund invests in.


Actual investment mix



The target currency hedging is 50% of non-NZD equity exposure and 100% of non-NZD fixed interest exposure (actual hedging level was 56.87% at the quarter end (this will change over time). Total unhedged foreign exposure is 24.47% of the net asset value.

*Other refers to investments that are unlikely to be stock exchange listed and can include impact investments, venture capital, private credit, private equity and unlisted property.

Notes
