What is the purpose of this update?

This document tells you how the InvestNow Russell Investments Global Fixed Interest Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Implemented Investment Solutions Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: aims to provide a total return, before costs and tax, higher than the Bloomberg Barclays Global Aggregate Index – New Zealand dollar hedged over the long term (3 years plus).

Strategy: provides exposure to a portfolio of international fixed interest securities and is actively managed using a multi-manager approach. Targets being fully hedged back to New Zealand dollars.

What are the risks of investing?

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.



How has the fund performed?

This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 30 September 2022.

What fees are investors charged?

Investors in the InvestNow Russell Investments Global Fixed Interest Fund are charged fund charges. In the year to 31 March 2022 these were:

Fund fees were reduced in December 2021. Hence going forward, we expect total fund charges to be less than in the table above. Estimated total fund charges in the current PDS are 0.59% (including GST).

The 'other management and administration charges' include fees and costs charged in underlying funds. The amount of fees and costs charged in underlying funds has been estimated.

Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds). Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year Anthony incurred a loss after fund charges were deducted of \$1,324 (that is -13.24% of his initial \$10,000). This gives Anthony a total loss after tax of \$967 for the period.

This shows the types of assets that the fund invests in.


Actual investment mix
