## What is the purpose of this update?

This document tells you how the InvestNow Antipodes Global Fund - Long has performed and what fees were charged. The document will help you to compare the fund with other funds. Implemented Investment Solutions Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

Objective: aims to achieve absolute returns in excess of the MSCI All Country World Net Index in NZ dollars over the investment cycle (typically 3-5 years).

Strategy: provides exposure to a diversified portfolio of international shares which is actively managed.

## What are the risks of investing?

## Example of how this applies to an investor iii

Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund when the fund received its first contribution, on 18 November 2021, and did not make any further contributions. At the end of the period, Anthony incurred a loss after fund charges were deducted of \$130 (that is -1.31% of his initial \$10,000). This gives Anthony a total loss after tax of \$171 for the period.




This shows the types of assets that the fund invests in.

#### Notes

- A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility. Market index returns have been used until November 2021 and fund returns thereafter.
- ii. As the InvestNow Antipodes Global Fund Long only started accepting contributions on 18 November 2021 historical fee information is not available. The fund charges represent our best estimates of the fees and expenses that will be charged to the fund. These have been estimated using information provided by the underlying fund manager and by reference to the underlying fund's disclosure documents.
- iii. As the fund has not existed for a full year, figures in this example are based on returns from the date of the first fund contribution (18 November 2021)
