What is the purpose of this update?

This document tells you how the InvestNow Smartshares Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

How has the fund performed?

Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund when the fund received its first contribution, on 5 July 2021, and did not make any further contributions. At the end of the year, Anthony incurred a loss after fund charges were deducted of \$1,188 (that is -11.88% of his initial \$10,000). This gives Anthony a total loss after tax of \$1,149 for the period.

This shows the types of assets that the fund invests in.


Actual investment mix



The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 69%. The actual hedging level can be anywhere in the 0% - 120% range. As at 30 September 2022, 68.86% of the fund's foreign currency exposure was hedged.

Notes

- A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. - ii. As the InvestNow Smartshares Growth Fund only started accepting contributions on 5 July 2021 historical fee information is not available. These have been estimated using information provided by the underlying fund manager and by reference to the underlying fund's disclosure documents.
