What is the purpose of this update?

This document tells you how the InvestNow Harbour Active Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Implemented Investment Solutions Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: aims to deliver returns in excess of the Official Cash Rate (OCR) plus 5% over rolling 5-year periods.

Strategy: provides exposure to a diversified fund that invests in a portfolio weighted towards growth assets but with some income asset exposure.

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Example of how this applies to an investor

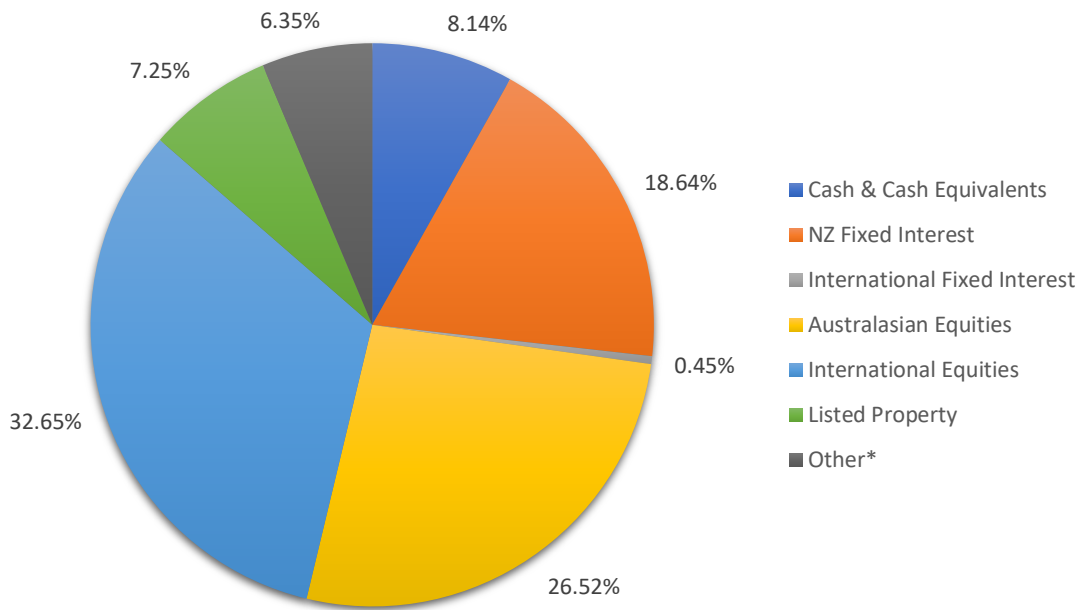
Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year Anthony incurred a loss after fund charges were deducted of \$1,845 (that is -18.45% of his initial \$10,000). This gives Anthony a total loss after tax of \$1,801 for the period.

What does the fund invest in?

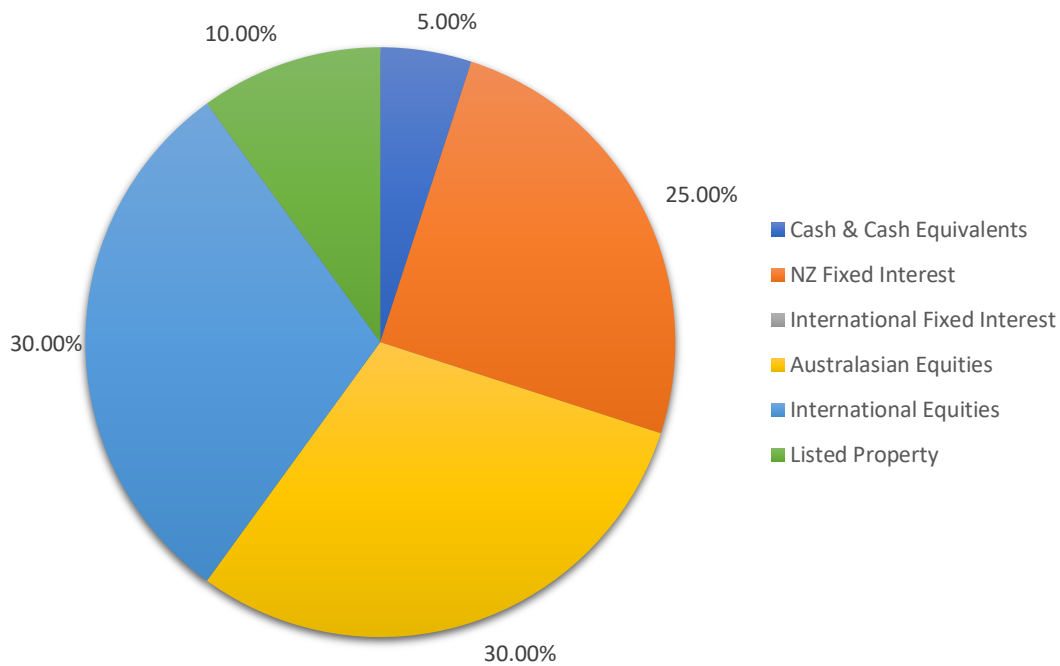
This shows the types of assets that the fund invests in.

Notes

- i. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. - ii. As the InvestNow Harbour Active Growth Fund only started accepting contributions on 19 April 2021 historical fee information is not available. The fund charges represent our best estimates of the fees and expenses that will be charged to the fund. These have been estimated using information provided by the underlying fund manager and by reference to the underlying fund's disclosure documents.
