

# Fund Update

## What is the purpose of this update?

This document tells you how the InvestNow Clarity Global Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Implemented Investment Solutions Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

Objective: aims to generate a better return than the MSCI All Country World ex-Tobacco Index (net dividends reinvested) in NZ dollars with 50% hedged to NZ dollars over the medium to long term.

Strategy: provides exposure to an actively managed global shares fund. The underlying investment manager uses a mix of fundamental and quantitative analysis to select companies.

# What are the risks of investing?

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.



## Annual Return Graph

## Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year Anthony incurred a loss after fund charges were deducted of \$1,013 (that is -10.13% of his initial \$10,000). This gives Anthony a total loss after tax of \$1,041 for the period.




# What does the fund invest in?

#### Notes

- i. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years.
