What is the purpose of this update?

This document tells you how the InvestNow Foundation Series Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Implemented Investment Solutions Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: The Fund aims to provide returns that are broadly in line with the return of the underlying fund's investment benchmark before fees and tax over the long-term.

Strategy: The Fund provides exposure to a diversified fund that invests in a portfolio weighted towards growth assets but with some income asset exposure.

What are the risks of investing?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



How has the fund performed?

Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year Anthony incurred a loss after fund charges were deducted of \$1,205 (that is -12.05% of his initial \$10,000). This gives Anthony a total loss after tax of \$1,200 for the period.



What does the fund invest in?


This shows the types of assets that the fund invests in.

Notes
