# What is the purpose of this update?

This document tells you how the InvestNow Russell Investments Hedged Global Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Implemented Investment Solutions Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

Objective: aims to outperform the MSCI ACWI Index – 100% Hedged to NZD - Net, before costs and tax, over the long term (3 years plus).

Strategy: provides exposure to an international shares fund that is actively managed using a multi-manager approach. The underlying fund targets being fully hedged back to New Zealand dollars.

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.



#### Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year Anthony incurred a loss after fund charges were deducted of \$1,502 (that is -15.02% of his initial \$10,000). This gives Anthony a total loss after tax of \$1,544 for the period.



# What does the fund invest in?


This shows the types of assets that the fund invests in.

#### Notes

- i. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility. Market index returns have been used until October 2020 and fund returns thereafter.
- ii. Total fund charges reflects the fees and expenses incurred by the underlying fund in which the InvestNow Russell Investments Hedged Global Shares Fund invests. This information has been sourced from the underlying fund manager in relation to the underlying fund's actual costs as a percentage of the average net asset value of the underlying fund.
