What is the purpose of this update?

This document tells you how the InvestNow Smartshares Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year Anthony incurred a loss after fund charges were deducted of \$1,152 (that is -11.52% of his initial \$10,000). This gives Anthony a total loss after tax of \$1,195 for the period.



What does the fund invest in?


This shows the types of assets that the fund invests in.

Actual investment mix



The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 69%. The actual hedging level can be anywhere in the 0% - 120% range. As at 31 December 2022, 63.33% of the fund's foreign currency exposure was hedged.

*Other refers to an investment in infrastrucure. The underlying investments are infrastructure securities listed in developed countries.

Notes

- i. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility. Market index returns have been used until July 2021 and fund returns thereafter.
- ii. As the InvestNow Smartshares Growth Fund only started accepting contributions on 5 July 2021 historical fee information is not available. The fund charges represent our best estimates of the fees and expenses that will be charged to the fund. These have been estimated using information provided by the underlying fund manager and by reference to the underlying fund's disclosure documents.
