

# **Fund Update**

#### What is the purpose of this update?

This document tells you how the InvestNow Macquarie Ethical Leaders Balanced Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Implemented Investment Solutions Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

# Description of this fund

Objective: Aims to provide capital growth over the longer-term with moderate levels of volatility.

Strategy: Provides exposure to a diversified fund that invests across asset types, with a slightly lower mix of income assets (e.g. bonds) and slightly higher mix of growth assets (e.g. shares). The underlying fund is managed to specific 'responsible investment' criteria which prohibit investments in certain companies or activities, and encourages investment in companies with strong environmental, social and governance characteristics.

# What are the risks of investing?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



## How has the fund performed?

#### **Annual Return Graph**



This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 31 December 2022.

## What fees are investors charged?

Investors in the InvestNow Macquarie Ethical Leaders Balanced Fund are charged fund charges. In the year to 31 March 2022 these were:

#### Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year Anthony incurred a loss after fund charges were deducted of \$1,190 (that is -11.90% of his initial \$10,000). This gives Anthony a total loss after tax of \$1,169 for the period.



## What does the fund invest in?


This shows the types of assets that the fund invests in.

#### Actual investment mix



The fund targets a position of exposure to foreign currency (excluding Australian dollar shares) being 69% gross hedged back to the New Zealand dollar. For Australian dollar shares, the underlying fund targets a position of exposure being 50% gross hedged

#### Notes

- i. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. - ii. Total fund charges reflects the fees and expenses incurred by the underlying fund in which the InvestNow Macquarie Ethical Leaders Balanced Fund invests.
