#### What is the purpose of this update?

This document tells you how the InvestNow Macquarie Ethical Leaders Hedged Global Fixed Interest Index Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Implemented Investment Solutions Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

# Description of this fund

Objective: aims to provide a return that closely matches the return of the Bloomberg Barclays MSCI Global Aggregate SRI Select ex-Fossil Fuels Index, fully hedged to the New Zealand dollar.

Strategy: provides exposure to a passively managed international fixed interest portfolio.

# What are the risks of investing?



# What fees are investors charged?

Investors in the InvestNow Macquarie Ethical Leaders Hedged Global Fixed Interest Index Fund are charged fund charges. In the year to 31 March 2022 these were:

#### Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year Anthony incurred a loss after fund charges were deducted of \$1,279 (that is -12.79% of his initial \$10,000). This gives Anthony a total loss after tax of \$962 for the period.


This shows the types of assets that the fund invests in.

## Notes
