What is the purpose of this update?

This document tells you how the InvestNow Smartshares Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Objective: designed for investors that want a growth investment option.

Strategy: provides exposure to a diversified fund that invests mainly in growth assets.

What are the risks of investing?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



How has the fund performed?

What fees are investors charged?

Investors in the InvestNow Smartshares Growth Fund are charged fund charges. In the year to $31\,\mathrm{March}\ 2023$ these were:

Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$848 (that is 8.48% of his initial \$10,000). This gives Anthony a total return after tax of \$777 for the period.



What does the fund invest in?


This shows the types of assets that the fund invests in.

Other refers to an investment in infrastrucure. The underlying investments are infrastructure securities listed in developed countries.

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 63.42%. The actual hedging level can be anywhere in the 0% - 120% range. As at 30 June 2023, 63.22% of the fund's foreign currency exposure was hedged.
