# What is the purpose of this update?

This document tells you how the InvestNow Foundation Series Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

# **Description of this fund**

Objective: to perform broadly in line with the return of its investment benchmark before fees and tax over the long-term.

Strategy: aims for high long-run returns by investing in a diversified portfolio weighted towards growth assets but with some income asset exposure.

# What are the risks of investing?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



# How has the fund performed?

# Annual Return Graph

#### What fees are investors charged?

Investors in the InvestNow Foundation Series Growth Fund are charged fund charges. In the year to 31 March 2023 these were:

#### Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$1,213 (that is 12.13% of his initial \$10,000). This gives Anthony a total return after tax of \$1,125 for the period.




#### What does the fund invest in?

# Notes

- i. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years.
