What is the purpose of this update?

This document tells you how the InvestNow Foundation Series US 500 Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: aims to provide returns that are broadly in line with the return of the underlying fund's investment benchmark before fees and tax over the long-term.

Strategy: aims for high long-run returns by investing in an underlying Exchange-Traded Fund (ETF) that invests in shares of the largest companies listed on exchanges in the United States.

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund when the fund received its first contribution, 17 February 2023 and did not make any further contributions. At the end of the period to 30 June 2023, Anthony received a return after fund charges were deducted of \$1,147 (that is 11.47% of his initial \$10,000). This gives Anthony a total return after tax of \$1,090 for the period.




What does the fund invest in?

Notes

- i. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years.
