## What is the purpose of this update?

This document tells you how the InvestNow Generate Focused Growth Fundhas performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

Objective: aims to provide a higher growth investment return over the long term through investment in nearly all growth assets.

Strategy: provides exposure to a diversified fund that invests into a portfolio weighted toward growth assets, but with a small allocation to income assets.

# Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund when the fund received its first contribution, 17 February 2023 and did not make any further contributions. At the end of the period to 30 June 2023, Anthony received a return after fund charges were deducted of \$476 (that is 4.76% of his initial \$10,000). This gives Anthony a total return after tax of \$470 for the period.



#### What does the fund invest in?


This shows the types of assets that the fund invests in.

Cash and cash equivalents includes the value of foreign exchange hedging derivatives related to the fund's off-shore investments. Listed Property includes investments in aged care companies. The Fund has an ability to invest in unlisted property and infrastructure investments as per limits set in the underlying fund's SIPO. Australasian equities includes an investment in unlisted New Zealand equities.

The fund's net foreign currency exposure was 34.13% of net asset value on the 30 June 2023. At target the fund's net foreign currency exposure is 32.50% of net asset value.



Cash and cash equivalents includes the value of foreign exchange hedging derivatives related to the fund's off-shore investments. Listed Property includes investments in aged care companies. The Fund has an ability to invest in unlisted property and infrastructure investments as per limits set in the underlying fund's SIPO. Australasian equities includes an investment in unlisted New Zealand equities.

# **Notes**

- i. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility. Market index returns have been used until May 2023 and fund returns thereafter.
- ii. As the InvestNow Generate Focused Growth Fund only started accepting contributions on 1 May 2023 historical fee information is not available. The fund charges represent our best estimates of the fees and expenses that will be charged to the fund. These have been estimated using information provided by the underlying fund manager and by reference to the underlying fund's disclosure documents.
