What is the purpose of this update?

This document tells you how the InvestNow Mint Diversified Income Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: aims to deliver a total return (through a combination of income and capital growth) in excess of the Consumers Price Index (CPI) by 3% per annum, before fees, over the medium to long-term.

Strategy: provides exposure to a diversified fund that invests across a number of asset classes both in New Zealand and internationally. These include cash, fixed interest, listed property, and equites.

What are the risks of investing?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

How has the fund performed?

What fees are investors charged?

Investors in the InvestNow Mint Diversified Income Fund are charged fund charges. In the year to 31 March 2023 these were:

Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$112 (that is 1.12% of his initial \$10,000). This gives Anthony a total return after tax of \$74 for the period.




What does the fund invest in?

The fund has 22% of its assets denominated in foreign currencies of which 94% was hedged to NZD.

Notes
