What is the purpose of this update?

This document tells you how the InvestNow Foundation Series Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: aims to provide returns that are broadly in line with the return of the underlying fund's investment benchmark before fees and tax over the long-term.

Strategy: provides exposure to a diversified fund that invests in a portfolio weighted towards growth assets but with some income asset exposure.

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.




How has the fund performed?

What fees are investors charged?

Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$1,743 (that is 17.43% of his initial \$10,000). This gives Anthony a total return after tax of \$1,626 for the period.



What does the fund invest in?


This shows the types of assets that the fund invests in.

Notes

- i. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. - ii. Total fund charges reflects the fees and expenses incurred by the underlying fund in which the InvestNow Foundation Series Growth Fund invests. This information has been sourced from the underlying fund manager in relation to the underlying fund's actual costs as a percentage of the average net asset value of the underlying fund.
- iii. The top 10 assets add up to more than 100% of NAV as the fund also has liabilities which offsets these assets.
